PARTIAL RELEASE OF  
TRADEMARK SECURITY AGREEMENT

This Partial Release of Trademark Security Agreement (“Partial Release”) is made as of March 15, 2024, by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., in its capacity as Trustee and as the collateral agent for the Secured Parties (in such capacity, together with its successors and assigns in such capacity, the “Collateral Agent”), in favor of Cloudbreak Health, LLC, a Delaware limited liability company (“Cloudbreak”), Language Access Network, LLC, a Delaware limited liability company (“LAN”), and Carenection, LLC, a Delaware limited liability company (“Carenection” and, together with Cloudbreak and LAN, collectively, the “Released Grantors” and each, a “Released Grantor”). Capitalized terms used but not otherwise defined herein have the respective meanings to them in the Trademark Security Agreement (as defined below).

WHEREAS, the Released Grantors, together with other Grantors party thereto, entered into that certain Trademark Security Agreement dated February 9, 2024 (the “Trademark Security Agreement”), with the Collateral Agent, notice of which was recorded on February 14, 2024 at the United States Patent and Trademark Office at Reel 8344, Frame 0982.

WHEREAS, each Released Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent for the benefit of each Secured Party, in and to all of each such Released Grantor’s right, title and interest in the Trademark Collateral granted by such Released Grantor under Section 2 of the Trademark Security Agreement, including, without limitation, the Trademark Collateral listed in Schedule I, and all goodwill connected with the use thereof and symbolized thereby (the “Released Trademark Collateral”).

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in the Released Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby, without recourse or warranty of any kind or nature, releases, terminates and discharges any and all of its interest in the Released Trademark Collateral, including all goodwill connected with the use thereof and symbolized thereby, and assigns, transfers and conveys to the Released Grantors the Security Interest in such Released Trademark Collateral.

This Partial Release is a partial release only and shall in no way affect the Collateral Agent’s right, title and interest in the Trademark Collateral other than the Released Trademark Collateral, nor shall this Partial Release affect the obligations of the Grantors, other than the Released Grantors, under the Trademark Security Agreement. Except as expressly set forth herein, this Partial Release shall not impair, alter, modify, amend or in any way affect any of the terms, conditions, obligations, covenants or agreements contained in the Trademark Security Agreement, which remain in full force and effect. After the date hereof, any reference to the Trademark Security Agreement shall mean the Trademark Security Agreement, as modified by this Partial Release.

The Bank of New York Mellon Trust Company, N.A., is executing this Partial Release not in its individual or corporate capacity but solely in its capacity as Collateral Agent under the Indenture (as defined in the Trademark Security Agreement). In acting hereunder, the Collateral Agent shall be entitled to all of the rights, privileges, immunities and indemnities granted to the Collateral Agent under the Indenture and the Security and Pledge Agreement (as defined in the Trademark Security Agreement), as if such rights, privileges, immunities and indemnities were expressly set forth herein.
