Assignee shall be substituted for MATERIA in all matters involving the MATERIA Marks and shall hold and enjoy all of MATERIA's rights with regard to the MATERIA Marks as fully and entirely as said interest could have been held and enjoyed by MATERIA had this assignment, transfer and conveyance not been made.

MATERIA further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the MATERIA Marks.

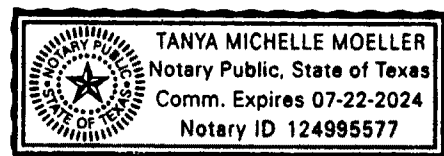
