- (c) all rights of priority (or to claim priority) attaching to the Trade Marks; and
- (d) all goodwill of the business associated with and symbolized by the Trade Marks.

FURTHER ASSURANCE

2. At the request of the Assignee, the Assignor undertakes to do all such reasonable acts and/or execute or procure the execution of all such documents as may reasonably be required to vest the Trade Marks in the Assignee or otherwise perfect the legal and beneficial title of the Assignee in and to the Trade Marks, all without further consideration.

COUNTERPARTS

3. The Assignment may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which shall be an original, but all of which together shall constitute one and the same instrument. 
