## RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of March 12, 2024, by JEFFERIES FINANCE LLC (“Jefferies”), as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”), in favor of REVSPRING, INC., a Delaware corporation (the “Grantor”). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them (whether directly or by reference to another agreement or document) in the Security Agreement (as defined below).

WHEREAS, the Grantor and the Collateral Agent are party to that certain First Lien Security Agreement, dated as of October 11, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered that certain First Lien Intellectual Property Security Agreement, dated as of October 11, 2018 (the “Intellectual Property Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on October 12, 2018 and at Reel/Frame 6455/0188;

WHEREAS, pursuant to the Security Agreement and the Intellectual Property Security Agreement, the Grantor granted to the Collateral Agent a security interest (the “Security Interest”) in all of its right, title and interest in and to the following (other than Excluded Property), whether then owned or thereafter acquired by the Grantor: (i) all Trademarks, including the trademark and service mark registrations and applications set forth in Schedule A hereto, together with the goodwill symbolized thereby; (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto; (iii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and (iv) any and all proceeds of, collateral for, income, royalties and other payments then or thereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing (collectively, the “Trademark Collateral”);

WHEREAS, the Grantor has requested the Collateral Agent to release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, hereby (i) terminates the Intellectual Property Security Agreement with respect to the Grantor, (ii) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (iii) re-assigns to the Grantor any right, title or interest it may have in the Trademark Collateral, together with all goodwill associated therewith, in each case without recourse to the Collateral Agent and without representation or warranty of any kind.

The Collateral Agent authorized the recordation of this Release with the USPTO at the Grantor’s expense. At the request and expense of the Grantor, the Collateral Agent hereby agrees to duly execute, acknowledge, procure an delivery any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
