## TRADEMARK ASSIGNMENT AGREEMENT

This **Trademark Assignment Agreement** (this “**Agreement**”) is made effective as of the date of the signature below (the “**Effective Date**”) and is made by and between GA Telesis, LLC, a limited liability company organized and existing under the laws of Florida, having an address at 1850 NW 49th Street, Fort Lauderdale, Florida 33309 (“**Assignor**”) and Koggi Holdings Corp. a British Virgin Island company, identified with the BVI Company Number 2073193 and headquartered at AV CR 19 No 95 - 20 Office 601 Torre Sigma, Bogotá, Colombia (“**Assignee**”). Assignor and Assignee are referred to collectively as the “**Parties**” and with respect to each a “**Party**”.

**WHEREAS**, the Assignor is the owner of trademarks that have common law trademark rights and are currently registered in the United States Patent and Trademark Office as follows: U.S. Trademark Registration No. 7208899 for the term “B” with design registered on October 31, 2023; U.S. Trademark Registration No. 7208900 for the term “BLOCKRAILS” registered on October 31, 2023; and U.S. Trademark Registration No. 7208901 for the term “FRAUDBLOCK” registered on October 31, 2023 (“the Marks”).

**WHEREAS**, the Assignee wishes to acquire all of the Assignor’s rights in the trademarks listed in this agreement.

**WHEREAS**, the Assignee wishes to acquire all of the Assignor’s rights, title, and interest in the Marks.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties covenant and agree as follows:

### **I. ASSIGNMENT:**

1) Assignor hereby irrevocably conveys, transfers, and assigns to the Assignee all of the Assignor’s right, title, and interest in the Marks, together with:

A) the goodwill of the business relating to the products and services on which the Marks are used and for which they are registered,

B) all income, royalties, and damages hereafter due or payable to the Assignor with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks, and

C) all rights to sue for past, present, and future infringement, or misappropriations of the Marks.

2) Assignor agrees that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee's rights conveyed pursuant to this Agreement.

3) Assignor agrees to make no further use of the Marks or any confusingly similar Marks in the United States and anywhere in the world, except as may be expressly authorized by the Parties in writing.

4) Assignor authorizes the United States Patent and Trademark Office to record the transfer of the Marks.
