RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of March 18, 2024 (the “Effective Date”), is made by JEFFERIES FINANCE LLC, in its capacity as Collateral Agent (the “Agent”), in favor of the grantor parties identified on the signature page hereto (collectively, the “Grantors” and each a “Grantor”).

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of March 5, 2019, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted and pledged to the Agent, in its capacity as Collateral Agent, a continuing security interest in, and lien on, certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered an Intellectual Property Security Agreement, dated as of March 5, 2019 (the “Intellectual Property Security Agreement”), for recorded with the United States Patent and Trademark Office;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on March 5, 2019 at Reel/Frame 048507/0201 and 6581/0435;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Intellectual Property Security Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its continuing security interest in, and lien on, the Collateral, including the Patents, including the patents and patent applications set forth in Schedule I attached hereto (the “Patent Collateral”) and the Trademarks, including the trademark registrations and applications set forth in Schedule II attached hereto (the “Trademark Collateral”). If and to the extent that the Agent has acquired any right, title or interest in and to the Collateral, including the Patent Collateral or Trademark Collateral, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Intellectual Property Security Agreement.

4. Further Assurances. The Agent hereby authorizes Grantors to make filings with the United States Patent and Trademark Office and agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
