TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of March 20, 2024, and made by JPMORGAN CHASE BANK, N.A., as administrative agent (the "Administrative Agent"), to POLY-WOOD, LLC, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 19, 2015, made by Grantor in favor of the Administrative Agent (the "Security Agreement"), a security interest was granted by the Grantor to the Administrative Agent in certain collateral, including the Trademarks (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on August 20, 2015, at Reel/Frame 5603/0460;

WHEREAS, the Administrative Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Administrative Agent hereby states as follows:

1. Trademarks. The term "Trademarks" as used herein, shall include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the intellectual property listed on Exhibit A hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of the Administrative Agent in the Trademarks.


