RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), effective as of March 15, 2024, made by COÖPERATIEVE RABOBANK U.A., NEW YORK BRANCH (formerly known as COÖPERATIEVE CENTRALE RAIFFEISEN-BOERENLEENBANK B.A., “RABOBANK NEDERLAND”, NEW YORK BRANCH), in its capacity as administrative agent for the Secured Parties (in such capacity, the “Administrative Agent”), with its principal offices at 245 Park Avenue, New York, New York 10167, in favor of FIELDALE FARMS CORPORATION, a Georgia corporation and FIELDALE FARMS POULTRY, LLC, a Georgia limited liability company (each a “Grantor”, and collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein have the meanings given to them, directly or by reference, in the First Trademark Security Agreement.

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of June 28, 2010 (the “First Trademark Security Agreement”), made by Grantors in favor of Administrative Agent, each such Grantor granted, collaterally assigned, and pledged to Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined in the First Trademark Security Agreement, the “First Trademark Security Agreement Trademark Collateral”) including without limitation those items listed on Schedule 1 hereto;

WHEREAS, the First Trademark Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on June 29, 2010, at Reel 004233, Frame 0622;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 13, 2015 (the “Second Trademark Security Agreement”), made by Grantors in favor of Administrative Agent, each such Grantor granted, collaterally assigned, and pledged to Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined in the Second Trademark Security Agreement, the “Second Trademark Security Agreement Trademark Collateral”, and together with the First Trademark Security Agreement Trademark Collateral, the “Trademark Collateral”) including without limitation those items listed on Schedule 2 hereto;

WHEREAS, the Second Trademark Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on March 13, 2015, at Reel 005477, Frame 0252; and

WHEREAS, Administrative Agent now desires to release the entirety of its security interest in the Trademark Collateral.

NOW, THEREFORE, as of the date hereof and for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby terminates, discharges, cancels and releases fully unto each Grantor the security interest in, and reassigns to the applicable Grantor any other interest Administrative Agent may have in such Grantor’s right, title and interest in and to, the Trademark Collateral (including without limitation those items listed on Schedules 1 and 2 hereto). The Administrative Agent hereby authorizes each Grantor and their successors, assigns or other legal representatives to file this Release with the United States Patent and

Trademark Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Administrative Agent's security interest in the Trademark Collateral.


