INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT (“Agreement”), entered into and effective on the date of execution (“the Effective Date”), between Motis Brands, Inc., a Delaware corporation having an address of N102 W19400 Willow Creek Way, Germantown, WI 53022 (“MBI”) and Motis LLC, a Wisconsin limited liability company having an address of N102 W19400 Willow Creek Way, Germantown, WI 53022 (“MOTIS”);

WHEREAS MOTIS was formerly known as Discount Ramps.com LLC (“DRC”) and is a wholly owned subsidiary of MBI.

WHEREAS the following entities were previously wholly owned subsidiaries of MBI (collectively “MERGED ENTITIES”):

Race Ramps LLC
HD Ramps LLC
MAC’s Custom Tie Downs, LLC
Elasco Products, LLC
PDN, LLC

WHEREAS INTELLECTUAL PROPERTY emanating from MOTIS or any of the MERGED ENTITIES was assigned to, filed, registered, or otherwise granted to MBI and exclusively licensed back to MOTIS and the MERGED ENTITIES for use thereof and furtherance of collective business goals. Such INTELLECTUAL PROPERTY set forth in Schedules A and B attached hereto.

WHEREAS in 2023 the MERGED ENTITIES were merged into MOTIS, with MOTIS being the surviving entity.

WHEREAS in the furtherance of corporate and business interests, MBI and its wholly-owned subsidiary MOTIS, desire for MOTIS to own such intellectual property directly.

NOW, THEREFORE, in view of the premises and covenants expressed herein, IT IS HEREBY AGREED, by and between the parties, as follows:

1. That MBI does hereby sell, assign, transfer, and deliver to MOTIS, and MOTIS does hereby purchase, receive, and acquire from MBI all right, title, and interest in and to the Patents listed in Schedule A, attached hereto.

2. That MBI does hereby sell, assign, transfer, and deliver to MOTIS, and MOTIS does hereby purchase, receive, and acquire from MBI all right, title, and interest in and to the Trademarks listed in Schedule B, attached hereto, along with any and all goodwill embodied therein, and any and all common law trademark rights therein.

3. MBI hereby acknowledges the receipt good and valuable consideration for the transfer of the INTELLECTUAL PROPERTY, and that such transfer furthers the mutual business interests of MBI and wholly-owned MOTIS.

4. MOTIS shall hold all right, title, and interest in and to the INTELLECTUAL PROPERTY as fully and completely as such right, title, and interest would have been held by MBI had this assignment not been made, including, but not limited to damages current and past under the INTELLECTUAL PROPERTY whether such damages are currently known or not.

5. This Agreement shall interpreted under the laws of the United States of America and the State of Wisconsin.

6. This Agreement may be modified only in writing, signed by the duly authorized representatives of both parties. Each party acknowledges that it has read this Agreement, understands it, and agrees to be bound by its terms, and further agrees that it is the complete and exclusive statement of the Agreement between parties which supersedes and merges all prior proposals, understandings, and all other agreements, oral and written, between the parties relating to this Agreement.

7. All terms and provisions of this Agreement shall be binding upon, shall inure to the benefit of and shall be enforceable by the parties and the successors and assigns of the parties.
