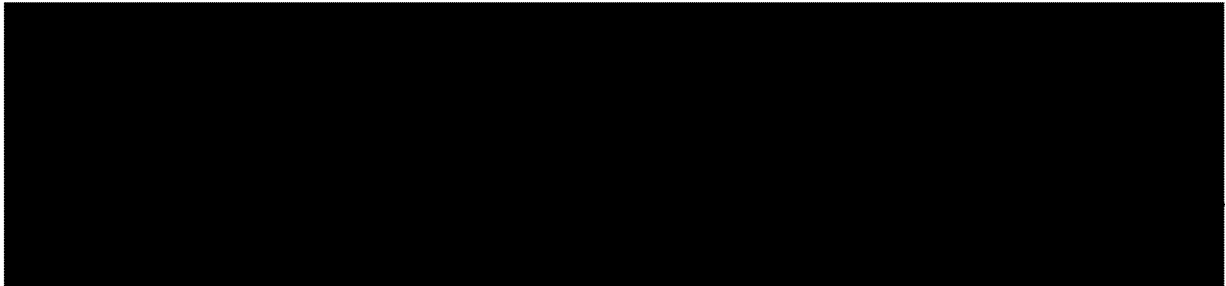
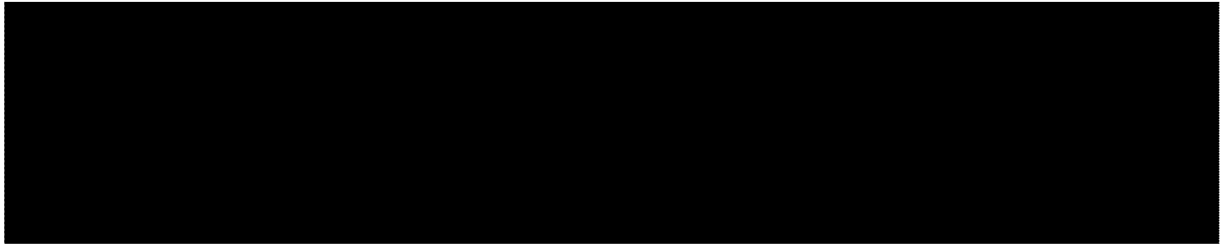
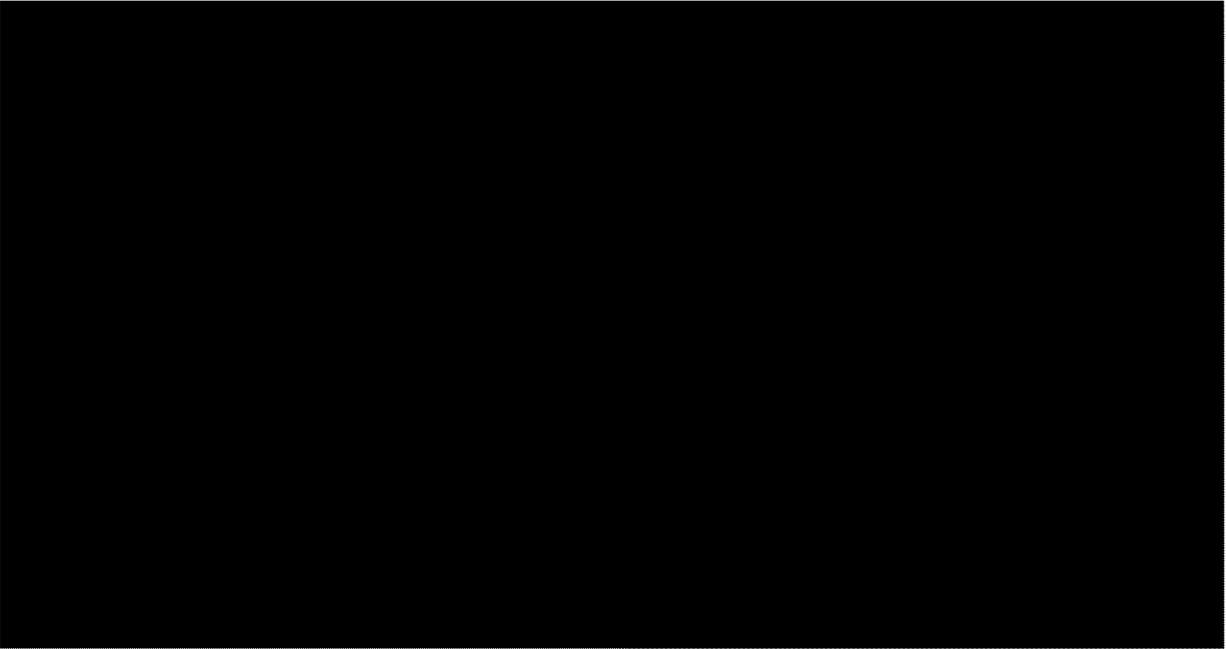
- (A) The Assignor is the registered owner of all rights associated with the trade mark application listed in Schedule 1 ("**Trade Mark**").


1. ASSIGNMENT


