## **TERMINATION AND RELEASE OF IP SUPPLEMENT TO SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF THE IP SUPPLEMENT TO SECURITY AGREEMENT (this “Release”), dated this 1<sup>st</sup> day of December, 2021, is by BMO HARRIS BANK N.A. (the “Secured Party”).

B. WHEREAS, Woodland Foods, LLC, an Illinois limited liability company, as successor-in-interest to Woodland Foods, Ltd., an Illinois corporation (the “Debtor”), granted Secured Party a security interest in all intellectual property constituting Collateral, including the Trademarks listed on Exhibit A attached hereto (the “Additional Intellectual Property”) pursuant to the IP Supplement to Security Agreement dated June 30, 2016 (the “IP Security Agreement”);

B. WHEREAS the Secured Party recorded its interest in the Trademarks with the United States Patent and Trademark Office (the “USPTO”) on July 1, 2016, in Reel 5825 Frame 0455; and

C. WHEREAS Debtor requests that the Secured Party release any and all right, title, and interest in and to the Trademarks, and the Secured Party agrees to release any and all such right, title, and interest.

NOW, THEREFORE, FOR VALUE RECEIVED, the Secured Party agrees as follows:

1) The Secured Party does hereby terminate and release the IP Supplement to Security Agreement and its security interest in and to all intellectual property constituting Collateral, including the Additional Intellectual Property, and all rights therein of any type or description.

2) The Secured Party hereby authorizes Debtor (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish the Secured Party’s rights and interest in the Trademarks.

3) This Release is governed by the laws of the State of Illinois without regard to the principles of conflicts of laws.

4) This Release shall be binding upon the Secured Party and its successors and assigns and inures to the benefit of Debtor and its successors and assigns.
