TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment"), is effective as of February 23, 2024 by and between Jessica Dimas, an individual residing in North Carolina (the "Assignor"), and She Sees LLC, a North Carolina limited liability company (the "Assignee").

Assignor does hereby transfer and set over to Assignee, its successors, and assigns, all of Assignor's right, title and interest in and to the Trademark together with the goodwill of the business associated with the Trademark and registration thereof, including any rights under common law, and the right to all remedies including damages, and accounting of profits or other proceeds and causes of action relating to past, present or future infringement or dilution of said Trademark.
2. Assignor agrees to execute and deliver such documents, and to take such actions, as may be reasonably requested by Assignee, its successors or assigns, to give effect to this Assignment and to vest, perfect, confirm, record or otherwise reflect or give effect to Assignee's rights as set forth herein.
3. Assignor hereby requests that the Director of the USPTO record Assignee as registrant of the Trademark, for the sole use and enjoyment of Assignee, its successors, legal representatives and assigns.
4. This Assignment may be executed in counterparts or duplicate originals, all of which shall be regarded as one and the same instrument. Electronic and digital copies of the Assignment, including properly executed PDF versions of the Assignment, shall be regarded as an original instrument by the parties.
