It is hereby certified upon behalf of each of the constituent corporation and the constituent limited liability company herein named, as follows:

FIRST: The name of the constituent corporation which is to be the surviving corporation, and which is hereinafter sometimes referred to as the "surviving constituent corporation", is Bloomsbury Publishing Inc. The date upon which its certificate of incorporation was filed by the Department of State is July 20, 2005. The corporation was originally formed under the name DIANA PUBLISHING INC.

SECOND: The name of the constituent limited liability company, which is being merged into the surviving constituent corporation, and which is hereinafter sometimes referred to as the "merged constituent limited liability company", is ABC - CLIO, LLC, and it was organized in the State of California on November 21, 2007. The merged constituent limited liability company has not filed an application for authority with the Department of State.
