ASSIGNMENT OF TRADEMARKS

This Trademark Assignment (the "Agreement") is made, entered into, and effective as of this 13th day of March 2024 (the "Effective Date") by and between Just Love Inc., a Delaware Corporation, located at 9450 Southwest Gemini Drive, 97008 Beaverton, Oregon (hereinafter referred to as "ASSIGNOR") and Madrid Ventures SL, a Spain Limited Company, located at Avenida Isla Graciosa, 1-28703 San Sebastian de los Reyes, Madrid- Spain, (hereinafter referred to as "ASSIGNEE").

WHEREAS, ASSIGNOR is the sole and exclusive owner of all rights, title and interest in and to the trademark applications (the "Marks") listed in **Appendix A** of this Agreement, all common law rights and moral rights relating to the Marks, and all rights arising out of or associated with the creation, design, manufacture, advertisement, distribution, offer for sale, and sale of goods in the field of downloadable software for social networking and dating under the Marks together with the goodwill of the business symbolized thereby (collectively, the "Assigned Rights").

WHEREAS, ASSIGNEE desires to acquire the Assigned Rights and accompanying goodwill from ASSIGNOR, and ASSIGNOR desires to assign said rights to ASSIGNEE;

NOW, THEREFORE, in consideration of the payment of \$428.39 USD and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby irrevocably assigns to ASSIGNEE all of its rights, title and interest throughout the world in and to the Assigned Rights. Such rights shall include without limitation all intellectual property rights, moral rights, and goodwill therein and thereto, and the right to bring, make, oppose, defend, and appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of the Assigned Rights whether occurring before, on, or after the date of this Agreement.




