TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Agreement”) is entered into this ____ day of March, 2024 (the “Effective Date”), by and between CH Digital Pty., a Limited company (Ltd.) of Australia with a principal place of business at 130, 126-130 Phillip Street Sydney AUSTRALIA NSW2000 (“Assignor”) and Centr LLC , a Delaware LLC with a principal place of business at 3300 Horseless Carriage Dr. Norco CA, 92860 (“Assignee”).

WHEREAS, Assignor is the owner of the United States trademark registration shown on the attached Schedule (the “Marks”);

WHEREAS, Assignor wishes to assign and transfer all rights in the Marks, and the registration therefor, and Assignee wishes to acquire all rights in the Marks, and the registration therefor from Assignor;

NOW, THEREFORE, in consideration of the payment of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties mutually agree as follows:

1. Assignment. Assignor hereby assigns, transfers and conveys to Assignee all worldwide right, title and interest in, to and under the Marks, including without limitation any application or registration therefor in any jurisdiction, any common law rights therein, and any trade name, business name or domain name incorporating the Marks, and any other rights Assignor may have in the Marks, together with the goodwill of the business connected with the use of and symbolized by the Marks, and together with all causes of action for the infringement of the Marks. Assignor and Assignee acknowledge and agree that Assignee is a successor of the entire business or portion thereof to which the Marks pertains, which business is ongoing and existing.

2. Warranties. Assignor represents and warrants that (i) it is the owner of all right, title and interest in the Marks, and has not granted any rights or interests in the Marks to any other person or entity, or otherwise encumbered the Marks in any manner; (ii) it has the authority to enter into this Agreement and fully perform all of its obligations hereunder; (iii) to its knowledge, the statements made in the applications for trademark registration of the Marks is true and correct; and (iv) to its knowledge, there is no claim or threatened claim that the Marks or its use of the Marks infringes, violates or breaches the rights of any other person or entity.

3. Entire Agreement. This Agreement constitutes the entire understanding of the parties, and supersedes any prior agreements or communications, concerning the subject matter described herein and therein.
