RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“Release”) is made and effective as of March 21, 2024 and granted by Lloyds TSB Bank plc (the “Agent”) for the Finance Parties under the Senior Facilities Agreement, dated as of November 5, 2012 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Facilities Agreement”) among the Original Obligors, the Original Lenders, the Facility Agent, and the Agent, in favor of InterMoor, Inc., (the “Grantor”).

WHEREAS, in connection with the Facilities Agreement, the Grantor has executed and delivered, as applicable the Master Security Agreement (defined below) or a written supplement in the form of Annex A thereto whereby Grantor became a party to the Security Agreement, dated as of November 30, 2012 in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “Master Security Agreement”);

WHEREAS, as required by the Security Agreement the Agent and the Grantor entered into that Grant of Security Interest in Trademark Rights dated as of December 20, 2012 (the “Trademark Security Agreement” and, together with the Master Security Agreement, the “Security Agreements”);

WHEREAS, pursuant to the Security Agreements, the Grantor pledged and granted to the Agent for the ratable benefit of the Secured Parties a security interest in and to all of the right, title and interest of the Grantor in, to and under the Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 004936, Frame 0790 on January 7, 2013; and

WHEREAS, the Grantor has requested that the Agent enter into this Release in order to effectuate, evidence and record the release of any and all right, title and interest the Agent and the Secured Parties may have in the Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby states as follows:

1. Release of Security Interest. Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates the Trademark Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of the Grantor in, to and under the Collateral including the trademarks listed on Schedule A hereto.
2. Recordation. Agent, at the Grantor’s sole cost and expense, hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Release.
3. Further Assurances. Agent agrees, at the Grantor’s expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and

all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

4. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).


