**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination"), is dated as of March 26, 2024, and made by **CITIZENS BANK, N.A.**, (the "Grantee"), to **JIPC MANAGEMENT HOLDINGS, INC.**, a California corporation; **INCREDIBLE ENTERTAINMENT, INC.**, a California Corporation; **JOHN'S INCREDIBLE PIZZA COMPANY, INC.**, a California corporation; **JIPC MANAGEMENT, INC.**, a California corporation; **JIPC VENTURES, INC.**, a California corporation; **INCREDIBLE CONCEPTS, INC.**, a California corporation; **JIPC NEWARK, LLC**, a California limited liability company; and **JIPC LAS VEGAS, LLC**, a California limited liability company (collectively, the "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of August 27, 2015, made by Grantor in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on August 28, 2015, at Reel/Frame 5611/0474;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, intending to be legally bound hereby, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.
