Pursuant to the provisions of Act 284, Public Acts of 1972 (profit corporations), Act 23, Public Acts of 1993 (limited liability companies), and Act 162, Public Acts of 1982 (nonprofit corporations), the undersigned executes the following Certificate of Conversion.

FIRST: That the name of the domestic corporation that is converting is National Automotive Parts Association. National Automotive Parts Association (the "Converting Entity") is converting into National Automotive Parts Association LLC, a Georgia limited liability company (the "Surviving Entity"), the internal affairs of which are to be governed by the Georgia Limited Liability Company Act at O.C.G.A. § 14-11-100 et. seq. The conversion is permitted by the law that will govern the internal affairs of the Surviving Entity and the Surviving Entity complies with that law in converting. The street address of the surviving business organization, the street address of the domestic corporation and the principal place of business of the surviving business organization are 2999 Wildwood Parkway, Atlanta, GA 30339.

SECOND: The Converting Entity has one member, Genuine Parts Company, a Georgia corporation, which possesses all voting rights.

THIRD: In the conversion, the entire membership interest in the Converting Entity will be converted into the entire membership interest in the Surviving Entity.

FOURTH: The plan of conversion was adopted by the Board of Directors of the Converting Entity and approved by the members of the Converting Entity in accordance with Section 745(1)(c) of the Nonprofit Corporation Act. The approval of the sole member was given by written consent as provided in MI Comp L § 450.2407(3) (2017).

FIFTH: The Surviving Entity will furnish a copy of the plan of conversion, on request and without cost, to any member of the Converting Entity.

SIXTH: No assumed names are being transferred.


SEVENTH: The conversion shall be effective at 11:59 p.m. Eastern Time, December 31, 2018.
