TERMINATION AND RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of March [28], 2024 (“Release”), is made by TEXAS CAPITAL BANK (“Lender”) with its principal place of business located at 2000 McKinney Avenue, Suite 700, Dallas, Texas 75201, in favor of RAPIDDEPLOY, INC., a Delaware corporation and EMERGENT COMMUNICATIONS INC., a Delaware corporation (together with RapidDeploy, Inc., each, a “Grantor” and collectively, the “Grantors”) with their principal place of business located at 310 Comal, Building A, Suite 200, #205, Austin, Texas 78702.

WHEREAS, pursuant to that certain (i) Loan and Security Agreement dated as of January 19, 2023 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Loan Agreement”) by and between Lender and Grantors, and (ii) Intellectual Property Security Agreement dated as of January 19, 2023 by and between Lender and Grantors (the “IP Agreement”, together with the Loan Agreement, the “Loan Documents”), Grantors granted and conveyed to Lender a security interest in the entire right, title and interest of Grantors in and to all of Grantors’ Intellectual Property, as more fully set forth therein;

WHEREAS, the IP Agreement was recorded with the Trademark Division of the US Patent and Trademark Office (“USPTO”) on January 23, 2023 at Reel No. 7950, Frame No. 0969, for the trademarks listed on Schedule A attached hereto.

WHEREAS, the IP Agreement was recorded with the Patent Division of the US Patent and Trademark Office (“USPTO”) on January 23, 2023 at Reel No. 062456, Frame No. 0227, for the patents listed on Schedule B attached hereto.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement, as applicable.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates the IP Agreement and terminates, cancels, discharges, and irrevocably releases the mortgage, pledge, and hypothecation and liens on and security interests in and to the entire right, title, and interest of Lender in and to all of Grantor’s Intellectual Property, including those listed on Schedule A attached hereto, granted pursuant to the Loan Documents;

(b) re-assigns, grants and re-conveys to the Grantor any and all of the right, title, and interest of Grantor that Lender may have acquired in and to all of Grantor’s Intellectual Property, including those listed on Schedule A; and

(c) authorizes the recordation of this Release with the USPTO, at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to its conflict of laws principles.
