RELEASE OF SECURITY INTERESTS IN TRADEMARK

This Release of Security Interests in Trademarks ("Release"), dated as of March 18, 2024, is made by I2 CAPITAL TRUST CORPORATION LTD, as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Agent"). Reference is hereby made to that certain Assignment of Grant of a Security Interest – Trademarks, dated February 22, 2021, (as amended, restated, supplemented, modified or otherwise changed from time to time, and including any grants of security interest made pursuant thereto, the "Security Assignment Agreement"), by and between LUCID TRUSTEE SERVICES LIMITED ("Predecessor Agent"), and the Agent. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Assignment Agreement.

WHEREAS, Licensing IP International S.a.r.l., ("Licensing IP") MG IP S.a.r.l, MG Licensing Europe S.a.r.l, and Nutaku Entertainment S.a.r.l., each as a grantor and the Predecessor Agent are parties to that certain Grant of a Security Interest – Trademarks, dated May 10, 2018 (the "US Agreement"), and recorded with the United States Trademark Office ("USPTO") on July 19, 2018 at Reel 6384, Frame 0854, concerning certain intellectual property (the "Trademarks").

WHEREAS, Licensing IP is party to that certain Grant of a Security Interest – Trademarks, dated May 10, 2018 (the "Canada Agreement"), and recorded with the Canadian Intellectual Property Office ("CIPO") on June 6, 2018, concerning the Trademarks.

WHEREAS, pursuant to the Security Assignment Agreement, the Predecessor Agent assigned and transferred to the Agent, all of its rights under the US Agreement and the Canada Agreement and all of its security interests in the Trademarks granted under the Agreement.

WHEREAS, the Trademarks include PORNMD, having a USPTO registration number, 4484877, CIPO registration numbers TMA936,584 and TMA 936,809 , owned by Licensing IP, and as set forth in Schedule I to this Release (the "PornMD Trademarks").

WHEREAS, the Agent desires to release any and all security interest it has in the PornMD Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) reconveys, releases, terminates, and forever discharges any and all security interests and other rights that were pledged, assigned, or granted to it in the PornMD Trademarks, and (ii) transfers and assigns to Licensing IP any right, title, or interest the Agent may have in, to, or under the PornMD Trademarks. The Agent hereby agrees to take such further actions and to execute such further documents as Licensing IP may reasonably request (all at Licensing IP's sole cost and expense) to effect and evidence this Release, and hereby authorizes Licensing IP to file this Release with the USPTO and CIPO.
