TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of April 1, 2024 (this "Release"), is made by U.S. Bank Trust Company, National Association (as successor to U.S. Bank National Association), as Collateral Trustee for the Secured Parties ("Collateral Trustee"), in favor of CSI Compressco Operating LLC, a Delaware limited liability company ("Operating"), CSI Compressco LP, a Delaware limited partnership ("LP"), and CSI Compressco Sub Inc., a Delaware corporation ("Sub Inc.", together with Operating and LP, collectively, the "Grantors").

WHEREAS, reference is made to that certain Pledge and Security Agreement, dated as of March 22, 2018 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the grantors party thereto and Collateral Trustee;

WHEREAS, pursuant to the Security Agreement, Grantors executed and delivered to Collateral Trustee, for the benefit of the Secured Parties, the Trademark Security Agreement dated as of March 22, 2018 ("IP Security Agreement"); and

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on May 1, 2018 at Reel 6378 Frame 0821.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Trustee, on behalf of the Secured Parties, and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement.

SECTION 2. Termination and Release. Collateral Trustee, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates the IP Security Agreement and terminates, cancels, discharges, reassigns and releases the security interest it has against the Trademark Collateral, including, but not limited to, the Trademarks, Trademark licenses and Trademark applications listed on Schedule A attached hereto;

(b) if and to the extent the Collateral Trustee has acquired any right, title or interest in, to or under any Trademark Collateral, assigns, transfers, conveys and delivers such right, title or interest to the Grantors; and

(c) authorizes the recordation of this Release with the USPTO at Grantors' expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
