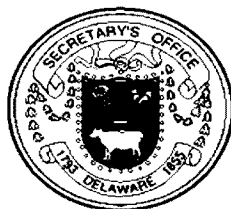

Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act, as amended (the "Act"), Edifecs, Inc., a Washington corporation (the "Company"), in connection with the merger of Health Fidelity, LLC, a Delaware limited liability company, with and into the Company (the "Merger"), hereby certifies as follows:

FIRST: The names and state of the limited liability company and state of incorporation or formation of the business entities to the Merger (the "Business Entities") are:

SECOND: An Agreement and Plan of Merger (the "Agreement") has been approved, adopted, certified, executed and acknowledged by, among other parties, each of the Business Entities in accordance with Title 6, Section 18-209 of the Act.

THIRD: Upon the effectiveness of the Merger, the Company shall be the surviving foreign corporation (the "Surviving Foreign Corporation"), and the name of the Surviving Foreign Corporation shall be "Edifecs, Inc."

FOURTH: The certificate of incorporation of the Company, as in effect immediately prior to the effectiveness of the Merger, shall, upon the effectiveness of the Merger, be the certificate of incorporation of the Surviving Foreign Corporation until thereafter amended in accordance with applicable law.

FIFTH: The Merger shall be effective at such time as this Certificate of Merger is duly filed and accepted by the Secretary of State of the State of Delaware in accordance with the Act.

SIXTH: An executed copy of the Agreement is on file at the office of the Surviving Foreign Corporation at 1756 114th Ave. SE, Bellevue, WA 98004.

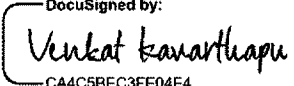
