ASSIGNOR further covenants that it is the lawful owner of the Marks, that upon information and belief the same is unencumbered, free and clear of all liens, and not subject to any claims of ownership, that there are no pending claims of infringement, and that ASSIGNOR has full right to make this ASSIGNMENT.

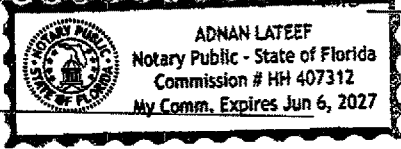

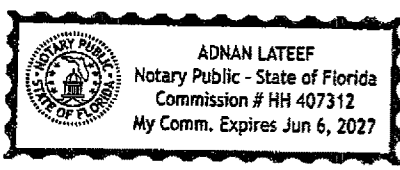
