RELEASE OF TRADEMARK COLLATERAL AGREEMENT

Dated as of April 1, 2024

This Release of Trademark Collateral Agreement, dated as of April 1, 2024 (the "Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Secured Party, with offices at 7711 Plantation Road, 1st Floor, MAC R4057-01R, Roanoke, VA 24019 (the "Secured Party"), in favor of PHILADELPHIA MACARONI COMPANY, a Pennsylvania corporation having its chief executive office at 760 South 11th Street, Philadelphia, PA 19147 (the "Debtor").

That certain Trademark Collateral Agreement ("Security Agreement"), dated as of July 22, 2019, by and among Debtor and Secured Party, which was duly recorded on July 23, 2019, at Reel 6700, Frame 0611 in the United States Patent and Trademark Office, whereby Debtor granted to the Secured Party for the ratable benefit of the Secured Party a continuing security interest in and to all of its right, title and interest in, to and under the trademarks set forth on Schedule 1 attached hereto, including all goodwill of the business connected with the use of and symbolized thereby ("Released Trademarks"), is hereby terminated, discharged, cancelled and released, without representation or warranty, and the Secured Party hereby re-assigns, transfers and conveys to the Debtor any and all rights, title and interests it may have in or to any of the Released Trademarks.

The Secured Party authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of Illinois.
