RELEASE OF SECURITY INTEREST IN TRADEMARKS

April 5, 2024

WHEREAS, Stevens Cabinets, Inc., a Delaware corporation d/b/a Stevens Industries, Inc. (the "Grantor"), pursuant to that certain Trademark Security Agreement entered into as of July 22, 2019 ("Trademark Agreement"), granted to Wells Fargo Bank, National Association, a national banking association ("Secured Party"), a security interest in and to all of Grantor's right, title and interest in and to the Trademarks (as defined in the Trademark Agreement), including without limitation the trademarks listed on Exhibit A attached hereto (the "Trademarks");

- (a) terminates and releases, without representation or warranty, all of Secured Party's right, title and interest in and to the Trademarks;
- (b) agrees that any power of attorney or similar rights granted by Secured Party to Grantor pursuant to or in connection with the Trademark Agreement is terminated; and
- (c) authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
