TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made and entered into as of November 15, 2023 (the "Effective Date"), by and between HN LA, Inc., a California corporation ("Assignor"), and HN IP, LLC, a Delaware Limited Liability Company ("Assignee")(collectively the "Parties").

WHEREAS, pursuant to that certain Intellectual Property Transfer Agreement dated effective as of December 31, 2021 (the "Transfer Agreement"), Assignor transferred, and agreed to transfer, certain trademarks, trademark applications and registrations, service marks, trade names, logo types, commercial symbols associated with the operation of "HEALTH NUT," and all goodwill associated therewith, to Assignee.

WHEREAS, Assignor owns certain rights, title, and interest in and to the trademarks and trademark registrations listed on Exhibit A hereto, and all goodwill associated therewith (collectively, the "Marks").

WHEREAS, certain trademark applications were passed to registration after the Transfer Agreement and this Assignment covers the assignment of those new trademark registrations, per the terms in the Transfer Agreement.

NOW THEREFORE, in consideration of the Transfer Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, agree as follows:

1. Transfer. As and when requested by the Assignee, from time to time after the Effective Date, Assignor agrees to sell, convey, transfer, assign, and deliver to Assignee, all of Assignor's rights, title and interest, in the United States of America and all foreign countries, in, to and under the Marks, including all common law rights connected therein; together with the goodwill symbolized thereby and associated therewith, and any registrations of and applications to register the Marks; and all income, royalties, fees, damages, and payments now or hereafter due or payable in respect to the Intellectual Property, and in and to any and all causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement or misappropriation of the Intellectual Property, as part of the entire business or portion thereof to which the Intellectual Property pertains as required b 15 U.S.C. Section 1060 and any other relevant statutory provisions or law.
2. Further Assurances. Assignor further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full rights, title and interest in and to the Intellectual Property
3. Government Authorization. Assignor hereby authorizes all appropriate governments to record this Assignment, and to issue or transfer all Intellectual Property, including specifically the Marks, to the Assignee as the legal and beneficial owner of all right, title, benefit, entitlement and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.

4. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the Parties and their successors and assigns. This Assignment documents Assignor's and Assignee's agreement of the Effective Date and thereafter, and it is made solely for the benefit of the Parties and their successors and assigns and no third party shall have any rights hereunder, including without limitation any third party beneficiary rights.
5. Amendments. This Assignment shall not be amended or modified except by a written instrument executed by the Parties.
6. Governing Law. This Assignment shall be construed and governed by the laws of the State of California, exclusive of its conflict of law rules.
7. Counterparts. This Assignment may be executed in any number of counterparts, any of which may be transmitted by facsimile or via portable document format by other electronic means, each of which shall be deemed to be an original and all of which together shall be deemed to be one and the same instrument. However, this Assignment shall be ineffective for any purposes whatsoever unless or until executed by all Parties hereto.
