ASSIGNMENT OF TRADEMARKS

TRADEMARK ASSIGNMENT, the Assignor hereby sells, transfers and assigns to the Assignee, its successors and assigns, the Assignor's entire right, title and interest in and to the Trademarks together with (i) the benefit of any use of the Trademarks by the Assignor (ii) the goodwill of the business relations to the Trademark and to the wares or services associated with it, (iii) all income, royalties and damages hereafter due or payable to Assignor with respect to the Trademark(s) to hold unto the Assignee absolutely, and (iv) all rights to sue for past, present and future infringement or misappropriations of the Trademark, and (v) the right to receive, maintain and otherwise manage and hold any and all pending applications or actual registrations.

The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the mark and its related property.

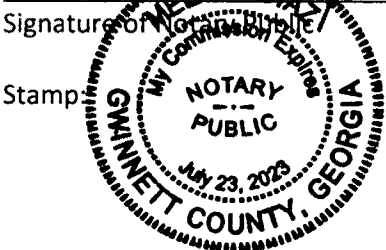
