TRADEMARK ASSIGNMENT

WHEREAS, GREENER DAYS, LLC, a Pennsylvania limited liability company, having a place of business at 668 Stony Hill Road, Suite 143, Yardley, Pennsylvania 19067 is the owner of the marks and registrations identified in the attached Appendix A as evidenced by their registrations in the United States Trademark Office ("USPTO") that are included in the bankruptcy estate ("Estate") of the ASSIGNOR. GREENER DAYS LLC has since changed its name and is presently known as GREENERWAYS LLC (hereinafter, "ASSIGNOR").

WHEREAS, ASSIGNEE has, with the permission of the bankruptcy court, purchased ASSIGNOR'S marks and registrations as identified in Appendix A and the machinery, trade secrets, knowhow, and goodwill associated with such marks and registrations.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Trustee does hereby assign unto said ASSIGNOR'S entire right, title and interest in and to the marks and registrations identified in Appendix A, together with (i) the benefit of any use of the marks by the ASSIGNOR (ii) the goodwill of the business relations to the marks and to the wares or services associated with them, and (iii) the right to bring action for any past infringement or improper use of the marks and to collect all income, royalties and damages hereafter due or payable to ASSIGNOR with respect to the marks to hold unto the ASSIGNEE absolutely.

ASSIGNOR further agrees that it shall render all reasonable assistance to ASSIGNEE, and will, from time-to-time, execute all instruments and documents necessary to maintain, preserve or protect said marks and said registrations, and to perfect the record title of ASSIGNEE in and to said marks and said registrations.
