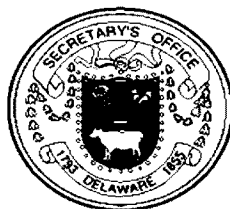

**FIRST:** That the Corporation was originally formed as U.S. Zinc Corporation, a Delaware corporation, and filed its original Certificate of Incorporation with the Secretary of State of the State of Delaware on December 21, 1988 (the "Certificate of Incorporation").

**SECOND:** That the Certificate of Incorporation of the Corporation be, and hereby is, amended by deleting Article 1 in its entirety and substituting in lieu thereof a new Article 1 to read as follows:

1. The name of the corporation is Everzinc Corporation.

**THIRD:** That the terms and conditions of this Certificate of Amendment of Certificate of Incorporation were duly adopted by the Board of Directors of the Corporation and the sole stockholder of the Corporation in accordance with Section 228 and Section 242 of the General Corporation Law of the State of Delaware.
