## TRADEMARK ASSIGNMENT

WHEREAS, Mitchell International, Inc., a Delaware corporation, with a business address at 9771 Clairemont Mesa Blvd, Suite A, San Diego, California 92124 (“Assignor”), owned the trademarks in Schedule A attached hereto (the “Registrations”), and the goodwill associated therewith (the “Marks”);

WHEREAS, Assignor and Emperion, Inc., a Delaware corporation, with a business address at 440 East Swedesford Road, Wayne, PA 19087 (“Assignee”), entered into a Separation and Distribution Agreement dated February 27, 2024 (the “Separation Agreement”) to separate and distribute the Independent Medical Examination (“IME”) business from Assignor and its affiliates to Assignee, including, without limitation, assigning the Registrations and Marks from Assignor to Assignee; and

WHEREAS, the transaction to separate the IME business from Assignor to Assignee closed on March 31, 2024.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is set out in the Separation Agreement and hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigned unto Assignee all right, title and interest in and to the Registrations and the Marks, together with any common law rights and the goodwill of the business symbolized therewith, as well as the right (but not the obligation) to assert the Registrations and the Marks and to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur.

2. Assignor and Assignee hereby authorize the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment.

3. This document may be executed in two or more counterparts, each of which shall be deemed to be an original and all such counterparts shall constitute but one and the same instrument, and a signature delivered by facsimile, e-mail, or other means of electronic transmission shall have the same force and effect as an original signature.
