FIRST SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This First Supplement to Intellectual Property Security Agreement (this “Supplement”) is entered into as of April 30, 2024 by and between FIRST-CITIZENS BANK & TRUST COMPANY (“Bank”) and the Grantors listed on the signature page hereto (individually and collectively, as the context requires, jointly and severally, “Grantor”).

RECITALS

WHEREAS, Grantor previously executed and delivered that certain Intellectual Property Security Agreement dated July 3, 2023 (as amended of record from time to time hereinafter, the “IP Agreement”) in favor of Bank, pursuant to which Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral, which was recorded with the Trademark division of the United States Patent and Trademark Office on July 5, 2023 at Reel 8214, Frame 0326 and the United States Copyright Office on July 5, 2023 at Volume 15016, Doc. No. 684.

WHEREAS, Grantor has developed additional copyrights and trademarks and desires to hereby confirm the pledge of, and grant of a security interest in, such additional intellectual property in favor of Bank.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

AGREEMENT

1. **Definitions.** All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreement.
2. **Supplement to Exhibit A.** Exhibit A to the IP Agreement is hereby supplemented, but not replaced, by Exhibit A-1 annexed hereto.
3. **Supplement to Exhibit C.** Exhibit C to the IP Agreement is hereby supplemented, but not replaced, by Exhibit C-1 annexed hereto.
4. **Miscellaneous:**
 - (a) Except as provided herein, all terms and conditions of the IP Agreement remain in full force and effect. Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - (b) This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
