

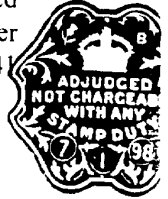

ASSIGNATION AND TRANSFER

between

NITTO WORLD CO., LIMITED, incorporated under the Companies Acts in England (number 02124389) and having its registered office at 41 Vine Street, London EC3N 2AA ("Nitto World")



and

SLC TURNBERRY LIMITED (formerly Randotte (No. 443) Limited), incorporated under the Companies Acts in Scotland (number 177810) and having its registered office at Level 2, Saltire Court, 20 Castle Terrace, Edinburgh EH1 2ET ("SLCT")

WHEREAS:

- (A) Nitto World is the beneficial owner of the Intellectual Property Rights (defined below);
- (B) Nitto World is a wholly-owned subsidiary of SLCT; and
- (C) The parties have agreed that Nitto World will transfer its Intellectual Property Rights to SLCT;

NOW THEREFORE THE PARTIES DO HEREBY AGREE as follows:-

1. Definitions

1.1 In this Agreement the following expressions shall, unless otherwise specified or the context otherwise requires, having the meanings set opposite them respectively:-

"Intellectual Property Rights"	the Trade Marks, Know-How, designs (registered or unregistered and including applications for registered designs and the right to apply for registered designs), copyright, moral rights and all other similar rights arising anywhere in the world, in or relating to the business of Nitto World;
--------------------------------	---

"Know-How"	all ideas, concepts, inventions, unpatented drawings, designs, models, specifications, data, formulae, processes and process techniques and any other technical or confidential information; and
"Trade Marks"	the registered Trade Marks as specified in the Schedule hereto and all continuations, renewals, and divisions thereof and all applications referred to in the Schedule hereto.

2. Nitto World hereby as beneficial owner and free from all liens, charges and encumbrances or other third party interest assigns to SLCT:-
  - (a) absolutely all property, right, title and interest in and to the Intellectual Property Rights and all goodwill associated therewith and all modifications, improvements and amendments thereto absolutely for the remainder of the terms which said rights and any renewals or extensions shall subsist; and
  - (b) the right to institute and maintain proceedings for infringement of the Intellectual Property Rights against any person who now or hereafter wrongfully uses the Intellectual Property Rights.
  
3. SLCT hereby acknowledges and agrees that no warranties, representations, undertakings or conditions (express or implied) are given or shall be deemed to be given by Nitto World in relation to the Intellectual Property Rights and that all warranties, undertakings or conditions are hereby expressly excluded.
  
4. Nitto World shall execute such other assignments, documents, forms and authorisations and make any declaration as may be requested by SLCT or required by any trade mark registry or by any other competent authority for vesting the full property, right, title and interest in the Intellectual Property Rights in SLCT or for conferring on SLCT all rights of action in relation to any infringement by third parties at the date hereof or hereafter.

5. This Agreement shall be governed by the laws of Scotland and shall be subject to the exclusive jurisdiction of the Scottish Court.

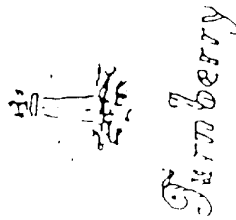
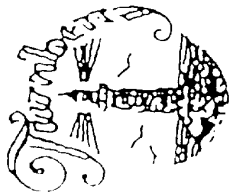
