

CONFIRMATION OF ASSIGNMENT OF TRADEMARKS

THIS AGREEMENT is made this 11th day of MAY, 1998 by and between PROJECT STRATEGIES CORPORATION, a Florida corporation having a place of business at 245 North Ocean Boulevard, Deerfield Beach, Florida 33441 ("ASSIGNOR") and DYE MAGNET INDUSTRIES, a Florida General Partnership, having a place of business at 245 North Ocean Boulevard, Deerfield Beach, Florida 33441 ("ASSIGNEE").

WHEREAS, ASSIGNOR owns and has a *bona fide* intent to use the mark COLOR MAGNET in connection with "laundry product in the nature of a fabric or sheet containing an additive for absorbing dye and color during wash" and the mark STAIN MAGNET in connection with "chemical composition used to remove stains from fabrics" (collectively "the Marks"); and

WHEREAS, ASSIGNOR has applied to register the Marks on the Principal Register of the United States Patent and Trademark Office based on ASSIGNOR'S *bona fide* intent to use the Marks in commerce in connection with the above-described goods, Application Serial No. 75/025,328 filed on November 29, 1995 for the mark COLOR MAGNET and Application Serial No. 75/345,748 filed on August 25, 1997 for the mark STAIN MAGNET;

NOW, THEREFORE, for good and valuable consideration which is set forth in a separate agreement between the parties, the receipt of which is hereby acknowledged, ASSIGNOR does hereby sell, assign, transfer and set over, unto ASSIGNEE, its successors and assigns, its entire right, title and interest worldwide in and to the Marks and the pending

Applications therefor, together with that portion of ASSIGNOR'S business in connection with which it has a *bona fide* intent to use the Marks.
