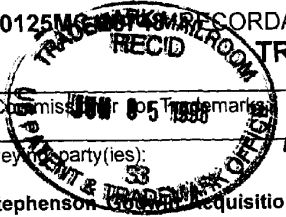

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
WILSON STEPHENSON GODWIN ACQUISITION CORP.**

Pursuant to the provisions of article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

ARTICLE ONE

The name of the Corporation is WILSON STEPHENSON GODWIN ACQUISITION CORP.

ARTICLE TWO

The following amendment to the articles of incorporation was adopted by the unanimous written consent of the Shareholders of the Corporation on July 31, 1997. The amendment alters or changes Article I of the Articles of Incorporation and the full text of the provision altered is as follows:

I

The name of the Corporation is DUCKSTER CORPORATION.

ARTICLE THREE

The number of shares of the Corporation outstanding at the time of such adoption was 10,000; the number of shares entitled to vote thereon was 10,000.

ARTICLE FOUR

The Shareholders, who are the holders of all 10,000 shares outstanding and entitled to vote on said amendment have signed a unanimous consent in writing pursuant to Article 9.10 adopting said amendment and any written notice required by Article 3.18 has been given.
