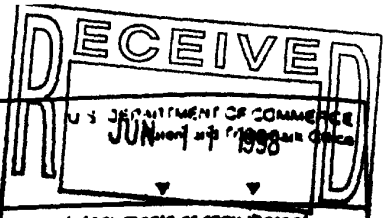


ASSIGNMENT
