TRADEMARK ASSIGNMENT

3. ICONtroll hereby covenants and agrees to cooperate with GREAT PLAINS so that GREAT PLAINS may enjoy to the fullest extent the rights, title and interest herein conveyed. Such cooperation shall include prompt execution of all papers prepared at the expense of GREAT PLAINS which are deemed necessary or desirable by GREAT PLAINS to perfect in it the rights, title and interest herein conveyed.

4. The terms, covenants and provisions of this Assignment shall inure to the benefit of GREAT PLAINS, its successors, assigns, and/or legal representatives, and shall be binding upon ICONtroll, its successors, assigns and/or other legal representatives.
