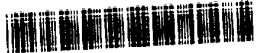

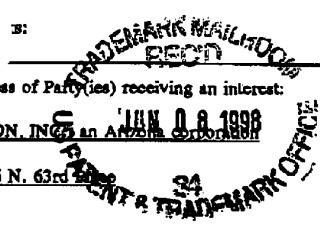

ASSIGNMENT


