I, the undersigned, being the President of ALL AMERICA

TERMITE & PEST CONTROL, INC., a Florida corporation, hereby certify that the following Amendment was adopted by Written Consent of the sole shareholder of the Corporation, in lieu of a Special Meeting, executed by such shareholder, who holds a sufficient number of votes to cause approval of the following Amendment, on March 12, 1997 and by Written Consent of the Board of Directors of the Corporation, in lieu of a Special Meeting, executed by all of the Directors of said Corporation on March 12, 1997.

FIRST: The name of this Corporation is All America Termite & Pest Control, Inc.

Second: Article I of said Articles of Incorporation is amended by deleting the provisions of said Article I as the same now exists, and by substituting in lieu thereof, the following:

ARTICLE I. NAME

The name of the corporation shall be SEARS TERMITE & PEST CONTROL, INC. The principal place of business of this corporation shall be 2625 Edgewater Drive, Orlando, Florida 32804.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
