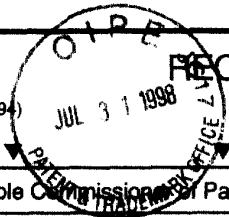


ACKNOWLEDGMENT




