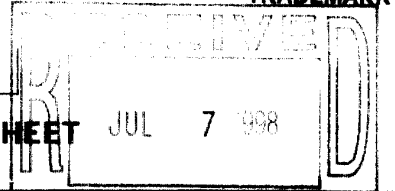

WHEREAS, Assignee desires to have a formal document for recordation purposes evidencing the assignment of the Trademarks;





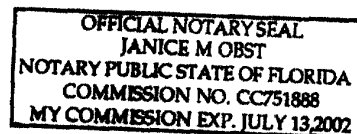
