

CONFIRMATORY ASSIGNMENT

WHEREAS, Fuji Trucolor Ohio, Inc., a corporation of the state of Ohio, located and doing business at 555 Taxter Road, Elmsford, New York 10523, is the owner of record of the entire right, title and interest in and to United States Trademark Registration No. 1,713,562 for the mark PHOTOCASH which was registered on September 8, 1992 and the good will of the business connected therewith;
