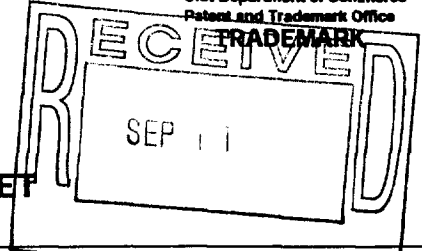


Assignment
