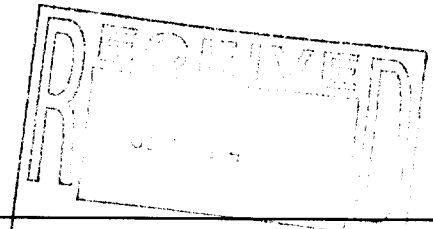


WHEREAS, Assignee is a successor to that portion of Assignor's business to which the marks pertain, which business is ongoing and existing.
