CONFIRMATORY TRADEMARK ASSIGNMENT

NOW, THEREFORE, for \$10.00, and other good and valuable consideration, the receipt of which is hereby acknowledged, it is confirmed that effective December 28, 1994, Assignor assigned, transferred and conveyed unto Assignee all right, title and interest in and to the Assigned Properties, together with the goodwill of the business symbolized by said Assigned Properties, and all foreign rights therein in all other countries, the same to be held and enjoyed by the Assignee for his own use and enjoyment, and for the use and enjoyment of his successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment and sale had not been made; together with all claims for damages by reason of past infringement of the Assigned Properties with the right to sue for and collect the same for Assignee's own use and behalf, and for the use and on behalf of his successors, assigns or other legal representatives.

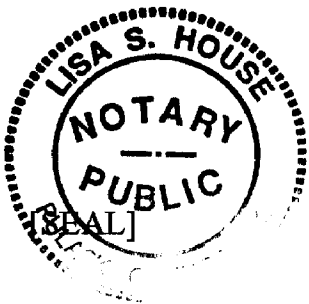
