**SUPPLEMENTAL TRADEMARK AND
LICENSE SECURITY AGREEMENT (BORROWER)**

This **SUPPLEMENTAL TRADEMARK AND LICENSE SECURITY AGREEMENT** ("Agreement") is entered into this 24th day of August, 1998 by and between **IMAGYN MEDICAL TECHNOLOGIES CALIFORNIA, INC.**, a California corporation ("Borrower"), and **BT COMMERCIAL CORPORATION**, having offices at 233 South Wacker Drive, Suite 8400, Chicago, Illinois 60606, as agent (the "Agent"), for the "Lenders" (as such term is defined in the Amended and Restated Credit Agreement referred to below).

WITNESSETH:

WHEREAS, the Agent, the Lenders, Borrowers and certain Affiliates thereof, have entered into a Credit Agreement dated as of December 30, 1997 (the "Existing Credit Agreement"), pursuant to which the Lenders have made loans, advances and other financial accommodations to the Borrowers thereunder; and

WHEREAS, the Agent, the Lenders, Borrowers and certain Affiliates thereof, have entered into that certain Amended and Restated Credit Agreement as of August 24, 1998 (the "Restated Credit Agreement") to accommodate additional loans, advances and other financial accommodations to the Borrowers thereunder; and

WHEREAS, the Borrower and the Agent entered into that certain Trademark and License Security Agreement dated as of December 30, 1997 ("Security Agreement") in conjunction with the Existing Credit Agreement; and

WHEREAS, the Borrower and Agent desire to amend the Schedules of the Security Agreement to reflect new trademarks and pending applications and licensed trademarks which arose or were identified after December 30, 1997, and which are subject to the Security Agreement pursuant to section 4 thereof;

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Borrower agrees as follows:

1. The recitals contained in this Agreement are an integral part hereof and this Agreement shall be construed in light of such recitals.
2. The Security Agreement is in full force and effect and is continuing in accordance with all of its terms.

3. The Schedules to the Security Agreement are hereby amended to reflect the inclusion, revision or deletion of the trademarks, trademark applications and licensed trademarks set forth on Schedule S1 hereto (the "Additional Trademarks"), all of which are subject to the continuing, first priority security interest granted to Agent for the benefit of the Lenders pursuant to the terms of the Security Agreement.


4. The trademarks, trademark applications and licensed trademarks set forth on Schedule S1 comprise all of the Additional Trademarks of Borrower as of this date.


