

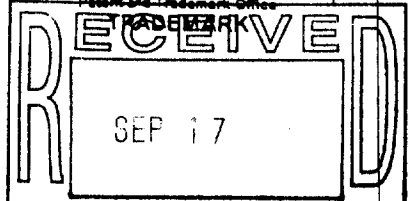

Chapter I. General Provisions

Article 1. (Corporate name) This company shall be called "Kabushiki Kaisha Hitachi Seisakusho" in Japanese and "Hitachi, Ltd." in English.

Article 2. (Corporate purpose) The purpose of this Company shall be to carry on the following business:

1. Manufacture and sale of electrical machinery and appliances.
2. Manufacture and sale of industrial machinery and appliances.
3. Manufacture and sale of rolling stock.
4. Manufacture and sale of telecommunication and electronic machinery and appliances.
5. Manufacture and sale of lighting and household machinery and appliances.
6. Manufacture and sale of optical and medical machinery and instruments.
7. Manufacture and sale of measuring and other general machinery and appliances.
8. Manufacture and sale of materials related to the products mentioned in any of the foregoing items.
9. Preparation and sale of software.
10. Leasing of the products mentioned in any of the foregoing items.
11. Telecommunication, information processing and information supply services.
12. Licensing of industrial property rights and know-how.

13. Undertaking of engineering related to any of the foregoing items.
14. Design, supervision and undertaking of construction work.
15. Any and all businesses relating to the foregoing.

Article 3. (Location of head office) The Company shall have its head office in Chiyoda-ku, Tokyo.

Article 4. (Method of giving public notices) The public notices of the Company shall be given by publication in the Mainichi Shimbun and the Nihon Keizai Shimbun, both published in the City of Tokyo.

Chapter II. Shares

Article 5. (Total number of shares authorized to be issued) The total number of shares authorized to be issued by the Company shall be 10,000,000,000 shares.

Article 6. (Par value of share) The par value of each par value share of the Company shall be ¥50.

Article 7. (Number of shares to constitute one unit) The number of shares to constitute one unit of shares of the Company
