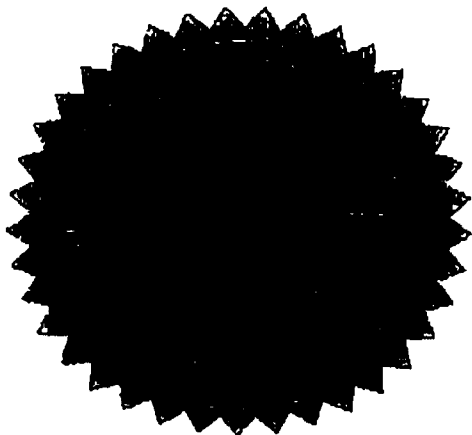

- 1. They are the duly elected and acting President and Chief Financial Officer, respectively, of Integris Security, Inc., a California corporation (the "Corporation").
- 2. Article I of the Articles of Incorporation of the Corporation shall be amended to read in its entirety as follows:

"Article I

The name of this corporation is: ValiCert, Inc."

- 3. The forgoing amendment of Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.
- 4. The forgoing amendment of Articles of Incorporation has been duly approved by the required vote of the shareholders of the Corporation in accordance with Section 902 and 903 of the California Corporations Code. The total number of shares of Common Stock entitled to vote is 935,053. The total number of shares of Preferred Stock entitled to vote is 1,795,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the Common Stock, voting as a class, more than 50% of the Preferred Stock, voting as a class, and more than 50% of the Common Stock and Preferred Stock, voting together.
