

# TRADEMARK ASSIGNMENT AGREEMENT

**THIS TRADEMARK ASSIGNMENT AGREEMENT** (this "Agreement") is made as of this 31st day of August 1998, by and between **ORANGEBURG INDUSTRIES, INC.**, a Tennessee corporation with an address at 400 Bohannon Avenue, Greeneville, Tennessee 37745 ("Assignor"), and **ENDOT INDUSTRIES, INC.**, a New Jersey corporation with an address at 60 Green Pond Road, Rockaway, New Jersey 07866 ("Assignee").

## WITNESSETH:

**WHEREAS**, Assignor is the owner of U.S. Trademark Reg. No. 1,232,613 for the mark "ORANGEBURG" and U.S. Trademark Reg. No. 1,170,054 for the mark "SP," both for use in connection with non-metallic conduits, ducts, pipe tubing, plastic pipes, and fittings for same for use in water drainage and sanitary systems, in class 11 (collectively, the "Orangeburg Trademarks"); and

**WHEREAS**, Assignor desires to assign and convey, and Assignee desires to acquire, the Orangeburg Trademarks, together with all good will and all other rights associated therewith;

**NOW, THEREFORE**, for and in consideration of the sum of One (\$1.00) Dollar and the mutual covenants herein contained, the parties hereto agree as follows:

1. Assignor hereby assigns, sets over and transfers to Assignee all of Assignor's right, title and interest in, to and under the Orangeburg Trademarks, all common law rights and all of the good will associated with the Orangeburg Trademarks, and the right to recover damages for any and all past infringements.

2. Assignee hereby accepts the assignment and conveyance of the Orangeburg Trademarks.


