Pursuant to Section 253 of the Delaware General Corporation Law, Mallinckrodt, Inc., a Delaware Corporation ("Mallinckrodt"), does hereby execute and acknowledge this Certificate of Ownership and Merger for the purpose of merging Mallinckrodt Anesthesia Products, Inc., a Delaware corporation, with and into Mallinckrodt, with Mallinckrodt as the surviving corporation.

Mallinckrodt owns all of the outstanding capital stock of Mallinckrodt Anesthesia Products, Inc. As of June 20, 1989, the Board of Directors of Mallinckrodt, by unanimous written consent of its members, adopted the following resolutions:

RESOLVED, that Mallinckrodt merge, and it hereby does merge into itself its subsidiary, Mallinckrodt Anesthesia Products, Inc., and assumes all liabilities and obligations thereof;

FURTHER RESOLVED, that the merger shall be deemed effective on July 1, 1989 at 9:00 a.m. Eastern Standard Time;

FURTHER RESOLVED, that the proper officers of Mallinckrodt be and they hereby are directed to make, execute and acknowledge a Certificate of Ownership and Merger setting forth a copy of the resolution to merge Mallinckrodt Anesthesia Products, Inc. into Mallinckrodt and to assume Mallinckrodt Anesthesia Products, Inc.'s liabilities and obligations and the date of adoption thereof and to file the same in the office of the Secretary of the State of Delaware and a certified copy thereof in the Office of the Recorder of Deeds of New Castle County.
