TRADEMARK ASSIGNMENT

WHEREAS, by virtue of the Assignment dated the 13th day of October, 1998 between (1) KLR, INC., a New York corporation, having a business address of 140 Esat 40th Street, New York, New York 10016 (hereinafter "KLR"), and (2) Richard J.
